



Driver License & ID Card Document Requirements for U.S. Immigrants

You must bring specific forms of proof of identification, Social Security, and residential address.

ONE Primary Identification

Original or certified copy. No photocopies.

- Valid Alien Registration receipt card, (Green card, Form I-551)
- I-797 with customer's A-number, stating the customer has been granted asylum
- I-551 stamp in passport or on I-94
- Immigration Judge's Order with the customer's A-number granting asylum
- I-797 or another form from the Bureau of Citizenship & Immigration Services with the customer's A-number, stating the customer's application for Refugee status is approved

ONE Social Security Number*

Must contain full social security number

- Original Social Security Card in your current full name
- W-2 Form
- Pay Stub
- SSA-1099
- Any 1099

***If you do not have a social security number, you must visit flhsmv.gov/whattobring for requirements.**

Name Change: If you have legally changed your name by marriage or court order, you must have your name changed on your Citizen and Immigration Services (USCIS) documents.

TWO Proofs of Florida Residential Address

Electronic notices are accepted. Please print & bring with you.

- Deed, mortgage, monthly mortgage statement, mortgage payment booklet, or residential rental/lease agreement, property tax documents
- Florida Vehicle Registration or Title; Florida Boat Registration or Title (if living on a boat/houseboat)
- Utilities Bills – (ex. Water, gas, electricity, cell phone, cable) (must be dated within the last 60 days)
- Automobile Payment Booklet (must be dated within the last 60 days)
- Selective Service Card
- Financial Statements (bank, credit cards or investment accounts) (must be dated within the last 60 days)
- Sexual Offender/Sexual Predator/Career Offender: (must be dated within the last 30 days) Certification of Address, section A, and the FDLE Registration form completed by the local sheriff's department
- Homeowner's and/or Automobile insurance policy or bill (last bill still in effect)
- Unexpired professional license issued by a government agency in the U.S.
- Employer Documentation - W-2 form or 1099 form, paycheck stub (must be dated within the last 60 days)
- A letter from a homeless shelter, transitional service provider, or half-way house verifying that the customer resides at the shelter address (must be dated within the last 60 days)
- Mail/Documents issued by Federal, State, County or City government agencies (must be dated within the last 60 days)
- Medical or Health card and/or Medical bill (must be dated within the last 60 days)

VETERANS requesting a veteran's designation on their license must present proof of an honorable discharge such as DD Form 2 Military Retired ID Card, DD Form 214 (copy 4, members copy), 100% Disabled Veteran Card or a verification of service letter from the VA.

The **REAL ID Act**, is a U.S. federal law that requires certain security, validation, and processes be used when issuing a compliant state driver license or ID card. These new cards can be accepted for official purposes including boarding commercial airline flights and entering federal buildings. We understand that these requirements can be challenging. We ask for your patience to please work with us so we may help you.

Sections 322.051 and 322.08, Florida Statutes, require that applicants provide proof of residential address documents to obtain a Florida Class E driver license or identification card. Two residential address documents from the approved documents list are required. If the applicant cannot provide two approved Florida residential address documents in their name, this affidavit must be used along with the documents provided by the individual whose name is on the proof of Florida residential address documents.
